15. CAPT. ROGER DUDLEY, natural son, b. c. 1552, d. 1585; m. before 1576, **SUSANNAH THORNE** (50-13), bp. 5 Mar. 1559/60, seen 29 Oct. 1588. (*TAG* 44: 131-132). This identification of Roger's (No. 15) father is probable; it is not proven.

4. SIR EDMUND MORTIMER (147-4), d. 17 June 1304, 7th Baron Mortimer of Wigmore; m. Margaret de Fienes, d. 7 Feb. 1333/4. (*NEHGR* 116: 16-17).

5. ISOLDE de MORTIMER, liv. 1336 (widow of Sir Walter de Balan); m. Hugh de Audley, Lord Audley, b. c. 1267, d. betw. Nov. 1325 & Mar. 1325/6, Ambassador to France, son of James de Audley and **ELA LONGESPEE** (143-3). (*CP* I, 346-347; IX, 499-501).

6. HUGH de AUDLEY, d. 10 Nov. 1347, 8th Earl of Gloucester; m. Windsor, 28 Apr. 1317, **MARGARET de CLARE** (28-5), d. 9 Apr. 1342. (*CP* V, 715).

6. ALICE de AUDLEY (sister of Hugh (6) above), d. 12 Jan. 1373/4; m. c. 14 Jan. 1326/7, **RALPH de NEVILLE** (44-5), b. c. 1291, d. 5 Aug. 1367, Lord Neville of Raby, q.v. (*CP* IX, 499-501).

1. WILLIAM de WARENNE, Named in the Magna Charta, 1215, 6th Earl of Surrey, d. London, 27 May 1240, son o-f Hamelin (bastard son of Geoffrey Plantagenet (see 161-10) and Isabella de Warenne; m. (2) bef. 13 Oct. 1225, **MAUD MARSHAL** (148-2, 155-3). (*CP* XII (1), 500).

2. JOHN de WARENNE, b. in or aft. Aug. 1231, d. aft. Michaelmas 1304, Earl of Surrey; m. Aug. 1247, Alice de Lusignan, d. 9 Feb. 1255/6, dau. of Hugh X de Lusignan and Isabella d'Angouleme. (*CP* XII (1), 503).

3. WILLIAM de WARENNE, b. c. 1256, killed in a tournament at Croydon, 15 Dec. 1286; m. prob. in June 1285, **JOAN de VERE** (121-4). (*CP* XII (1), 507).

2. JOHN de WARENNE (151-2); m. Alice de Lusignan.

3. ELEANOR de WARENNE, b. 1251, liv. 1282; m. York, 8 Sept. 1268, Sir Henry de Percy, Knt., b. c. 1235, d. 29 Aug. 1272, Lord Percy. (*CP* X, 455).

4. SIR HENRY de PERCY, Lord Percy, b. posthumous at Petworth, c. 25 Mar. 1273, d. betw. 2 and 10 Oct. 1314; m. Eleanor Fitz Alan, d. July or Aug. 1328. (See note at end of line.) (*CP* X, 456).

5. HENRY de PERCY. K.G., b. c. 1299, d. end of Feb. 1351/2, Lord Percy of Alnwick, M.P., 1322-1352; m. **IDOINE de CLIFFORD** (8-7).

Sussex, on the death s.p. of his brother, John de Bohun; m. as her 1st husb. Joan, d. betw. 8 Dec. 1321 & 23 June 1324, dau. and coheir of Sir William de Braiose of Bramber and Gower, d. 1326, 2nd Lord Braiose, a descendant of Llewelyn ap Iorwerth, Prince of North Wales, presumably by his wife Joan, illeg. dau. of King **JOHN** (161-12). (*CP II*, 200, 302-4; *The Genealogist* (n.s.), XXVIII: 5-6; I.J. Saunders, *English Baronies* (Oxford, 1960), p. 108).

6. SIR JOHN de BOHUN of Midhurst, b. Todham, 14 Nov. 1301, d. 5 Dec. 1367, accompanied Edward III to Ireland, 1331, and to France, 1346, cr. by writ, 10 Oct. 1359, Lord Bohun; m. (1) bef. 1326, Isabel, d. bef. 1342, perhaps dau. of Sir Henry de Tregoz of Goring, Sussex. (*CP II*, 200-1; *The Genealogist* (n.s.), XXVIII: 7-8).

7. JOAN de BOHUN, seen 24 Sept. 1349; m. John de Lisle of Gatcombe in the Isle of Wight, b. 13 June 1324, d. 31 Mar. 1349. (*The Genealogist* (n.s.), XXVIII: 8-9).

8. ELIZABETH de LISLE, seen 13 Sept. 1369, heir of her brother, John de Lisle, who d.s.p. 3 Sept. 1369; m. John de Bramshot. (*The Genealogist* (n.s.), XXVIII: 9).

9. WILLIAM BRAMSHOT, lord of the manor of Gatcombe in the Isle of Wight, b. c. 1370; m. c. 1395, Joan. (*Visitation of the County of Sussex, 1530 and 1633-4* (*Harl. Soc. Publ.*, vol. 53), p. 44).

10. JOHN BRAMSHOT, b. c. 1400, d. 1468, lord of the manors of Gatcombe, Calbourne, and Whitwell, in the Isle of Wight; m. 1444, as her 1st husband, Katherine, dau. of Sir John Pelham, Chamberlain to Queen Katherine, consort of Henry V, by Joan de Courcy, member of the Queen's Household. (*CP IV*, 480 note *a*; John Comber, *Sussex Genealogical Collections* (Cambridge, 1933), III: 204-5; *Sussex Archaeological Collections*, LXIX: 67-8).

11. ELIZABETH BRAMSHOT; m. John Dudley, Esq., of Altherington, Sussex, d. bef. 26 June 1501, sheriff of Sussex and Surrey, 1484-5, 2nd son of Sir John de Sutton, K.G., 1st Lord Dudley, by **ELIZABETH BERKELEY** (80A-8). (*CP IV*, 480 note *a*).

12. EDMUND DUDLEY, ESQ., b. c. 1462, beheaded 18 Aug. 1510, M.P., Speaker of the House of Commons, 1504, Privy Councillor, Chancellor of the Exchequer; m. Elizabeth, dau. of Edward Grey, Lord Lisle, by whom he was the father of John Dudley, Duke of Northumberland. By an unknown mistress, Edmund Dudley left illegitimate issue. (*CP IV*, 480 note *a*; *DNB VI*, 100-102).

13. SIMON DUDLEY, natural son, b. 1505, d. 1555, of Elmley Lovett, co. Worcester, and Hackney, Middlesex, member of the Household of Henry VIII, he was an officer at the coronation of Queen Anne Boleyn, and in 1544 accompanied the King to France; m. (1) bef. 1533, Emme, seen 5 Sept. 1543, dau. of Thomas Saunders. (*TAG 44*: 129-30).

14. JOHN DUDLEY, GENT., of Hackney, Middlesex, b. c. 1528, d. bef. 15 Feb. 1592/3, Serjeant of the Pastry of Queen Elizabeth I, had a grant of arms, 1588. By an unknown mistress, he left illegitimate issue. (*TAG 44*: 130-1, 135).

2. **SIBYL MARSHAL** (149-2); m. William, de Ferrers, Earl of Derby. (*CP* IV, 199).

3. **ISABEL de FERRERS**, d. by 26 Nov. 1260; m. as his 2nd wife, Sir Reynold de Mohun of Dunster, Somerset, a minor 1228, d. 20 Jan. 1257/8, Justice of Common Pleas, Chief Justice. (*CP* IX, 19-21).

4. **ISABEL de MOHUN**; m. Sir Edward Deincourt, 1st Lord Deincourt, d. 6 Jan. 1326/7; son of Sir John Deincourt by Agnes Neville, widow and 2nd wife of Richard de Percy who d. bef. 18 Aug. 1244; Agnes, who d. bef. 20 July 1293, was the dau. of Sir Geoffrey de Neville of Raby, co. Durham. (*CP* IV, 118-20; IX, 494-5).

5. **JOHN DEINCOURT**, d.v.p.; m. unidentified wife. (*CP* IV, 120).

6. **SIR WILLIAM DEINCOURT**, 2nd Lord Deincourt, ae. 26+ in 1326/7, d. 2 June 1364; m. bef. 26 Mar. 1326, **MILICENT la ZOUCHE** (74-6), d. 22 June 1379, dau. of **SIR WILLIAM la ZOUCHE** (74-5), 1st Lord Zouche (74-5) of Haryngworth, by Maud Lovel, dau. of John Lovel, 1st Lord Lovel of Titchmarsh by his 1st wife, Isabel de Bois. (*CP* IV, 120-22; XII (2), 97, 938-940).

7. **MARGARET DEINCOURT** (74-8), d. 2 Apr. 1380; m. by Trinity, 13 Apr. 1372, **SIR ROBERT de TIBETOT** (2-7), 3rd Lord Tibetot, b. 1341, d. 13 Apr. 1372. (*CP* XII (2), 97).

8. **MARGARET de TIBETOT**, ae. 6+ in 1372, d. betw. 13 Apr. & 14 May 1431; m. (1) bef. 23 Apr. 1385, Sir Roger le Scrope, 2nd Lord Scrope, b. bef. 1373, knighted bef. 23 Nov. 1385, d. 3 Dec. 1403. (*CP* XI, 541-2; XII (2), 97 note *i*).

9. **SIR RICHARD le SCROPE**, 3rd Lord Scrope, b. 31 May 1394, present at Agincourt, 25 Oct. 1415, d. 29 Aug. 1420; m. bef. 31 Dec. 1413, **MARGARET NEVILLE** (46-8), dau. of **RALPH NEVILLE** (45-7), 1st Earl of Westmorland by his 1st wife, **MARGARET STAFFORD** (136-8); d. 3 Edw. IV. (*CP* XI, 542-3).

2. **SIBYL MARSHAL** (149-2); m. William de Ferrers, 5th Earl of Derby.

3. **SIBYL de FERRERS**, seen 5 Oct. 1273, 4th dau.; m. bef. 21 Sept. 1247, as his 1st wife, Sir Francis de Bohun of Midhurst, Sussex, d. 14 Sept. 1273, son of Savary de Bohun of Midhurst by Cicely, dau. of Geoffrey Fitz Piers, Earl of Essex by (2) wife Avelina. (*CP* II, 199; IV, 199; V, 122-4; *The Genealogist* (n.s.), XXVIII: 1-2, XXIX: 64).

4. **SIR JOHN de BOHUN** of Midhurst, Sussex, and Ballymadden, co. Kildare, ae. 26 on 14 Sept. 1273, d. 28 Sept. 1284, summoned to attend Edward I at Shrewsbury, 28 June 1283; m. c. 1274, Joan, b. Dec. 1256, d. sh. bef. 23 Mar. 1327/8, only dau. and heir of Bartholomew de la Chapelle of Waltham, co. Lincoln, d. bef. 17 July 1258, Serjeant of the King's Chapel. (*CP* II, 199-200, 303-4; *The Genealogist* (n.s.), XXVIII: 2-4).

5. **JAMES de BOHUN**, 2nd son, of Ballymadden, co. Kildare, b. Ford, 3 Feb. 1280/1, d. sh. bef. 30 May 1306; had seizin of the manor of Midhurst,
