WAR IN TEXAS.—It appears from accounts from Texas received by us of New Orleans, that a Mexican Army, under the command of General Arista, has taken up arms and that the people of the place have taken up arms in return. The latter is a very singular circumstance. The New Orleans paper embraces the particular notice.

NEW ORLEANS, Oct. 13.—It is said that General Gen. Cos has landed near the intelligence of the Brazos with 400 men, with the intention of joining the 700 Federal troops stationed at San Antonio de Bexar, and marching on to the city of San Antonio. He has issued a Proclamation, in which he declares that he will collect the revenues, disarm the citizens, establish a military government, and confiscate the property of those who are not loyal to the Government. He has also written to several citizens of San Antonio, in which he offers them the choice of joining the Federal cause, or of being treated as rebels.

Information was received last night by express, that Gen. Cos had taken up arms with 400 men, near the mouth of the Brazos. An expedition is now raising in the lower country to take the field against him. It is expected that each man will supply himself with provisions, arms and ammunition. Arrangements will be made for permanent supplies as soon as possible.
