

John² Allen was accused of raping Ann Chase and thereby fathering her child in 1669. daughter of Aquila and Ann (Wheeler) Chase, q. v. He was probably the Lieutenant John Allen who was wounded in a fight against the French and Indians at Maquoit in 1691. In 1692, he testified against the accused witch Susanna Martin, although in the same year he and his wife signed a petition supporting Mary Bradbury, another accused witch. [Davis Mass. & Maine Families," 1:8]

William¹ Allen (d. 1686) and Ann (Goodale) Allen (c1618-1678)

WILLIAM¹ ALLEN was born in England, perhaps about 1615, and appeared in Salisbury, Mass. in 1639, when he participated in the first division of town lands. He practiced his trade as a house carpenter in Salisbury for the rest of his life.¹

Ann² Goodale (Richard¹) was born in England about 1618.²

William Allen and Ann Goodale were probably married in early 1639, since their first known child was born in January 1640.

Ann Allen died in May, 1678.3

William married, as his second wife, Alice (_____) (Roper) Dickinson, widow of John Roper and John Dickinson.⁴

William Allen of Salisbury made his will on 16 Apr 1674 and added a codicil on 7 Nov 1676. He mentions his wife Ann [the will and codicil were made before she died]; his sons John, William, Benjamin, Joseph, Richard, and Jeremiah; his daughters Abigail Wheeler, Hannah Ayers, Mary Hewes, and Martha Hubbard; his son[-in-law] George Hewes; and his brother Goodale.⁵

William Allen widowed Alice for the third and last time when he died in Salisbury on 18 Jun 1686.⁶ Administration was granted on his estate on 22 Jul 1686 in Boston.⁷ The inventory of his estate totaled £280.17s.⁸

Alice Allen died on 1 Apr 1687.9

William and Ann (Goodale) Allen had the following children, all born in Salisbury:

- i. **Abigail Allen**, born on 4 Jan 1639/40. She married Henry Wheeler about 1659. He was the son of John and Ann (Yeoman) Wheeler, 12 q. v.
- ii. **Hannah Allen**, born on 17 Jun 1642.¹³ She married Peter Ayer of Haverhill on 1 Nov 1659.¹⁴ He was the son of John and Hannah (Evered?) Ayer,¹⁵ *q*.
- iii. **Mary Allen**, born on 29 Jul 1644. ¹⁶ She married George Hewes ¹⁷ and was living in Salisbury in 1687 when she was admitted to the Salisbury church. ¹⁸
- iv. Martha² Allen, born in 1646. ¹⁹ She married Richard Hubbard, *q. v.*
- v. Lieutenant **John Allen**, born on 9 Oct 1648.²⁰ He married Mary (Pike) Andros in August 1674.²¹ She was born in Salisbury on 5 Aug 1647, the daughter of Robert and Sarah (Sanders) Pike,²² and the widow of Jedediah Andros. Mary Allen died on 28 Apr 1695.²³ John died, suddenly, on 27 Feb 1696/97.²⁴

- vi. Ensign **William Allen**, born on 2 Oct 1650.²⁵ He married Mary Harris on 5 Jul 1674.²⁶ She was the daughter of John and Bridget Harris of Rowley.²⁷ He and his wife signed the Mary Bradbury petition in 1692.²⁸ William died in Salisbury on 10 May 1700.²⁹ Mary died at Greenland, N. H., at the home of her son William, on 23 Jan 1720/21.³⁰
- vii. **Benjamin Allen**, born in 1652,³¹ a blacksmith by trade.³² He married (1) Rachel Wheeler on 3 Sep 1686.³³ Rachel was the widow of Henry Wheeler, son of Henry Wheeler and Benjamin's sister Abigail (Allen) Wheeler.³⁴ She died on 5 May 1694.³⁵ He married (2) Hopestill Leonard of Rehoboth or Taunton.³⁶ He died on 3 Sep 1723 in Rehoboth.³⁷
- viii. Captain **Joseph Allen**, born on 13 Oct 1653.³⁸ He married (1) Rachel Griggs in Gloucester, Mass. on 29 Jul 1680.³⁹ She died on 26 Apr 1684 in Gloucester.⁴⁰ He married (2) Rose Howard on 20 Nov 1684 in Gloucester.⁴¹ He died in

- Gloucester on 6 Oct 1724. As Rose died there on 27 Oct 1724, about 60 years old. As
- ix. **Richard Allen**, born on 8 Nov 1655,⁴⁴ died in Salisbury on 8 Jun 1678⁴⁵
- x. **Ruth Allen,** born on 19 Feb 1657/58. ⁴⁶ She is not named in her father's will, so she apparently had died by 1674. ⁴⁷
- xi. Lieutenant **Jeremiah Allen**, born on 17 Feb 1658/59.⁴⁸ He married (1) Ann Bradbury between 1686 and 1689.⁴⁹ Ann was born in Salisbury on 21 Nov 1666, the daughter of Wymond and Sarah (Pike) Bradbury.⁵⁰ She died on 26 Jan 1732/33.⁵¹ Jeremiah married (2) Hannah Walker on 20 Nov 1735.⁵² Jeremiah died on 20 Jul 1738.⁵³ Hannah died on 12 Oct 1753.⁵⁴
